

Affidavit

as a bidder within the Tender Procedure for the selection of an Air Operator to provide scheduled air services between Oradea (IATA code: OMR) and Warsaw (IATA code: WAW) airports, according to the Invitation to Tender (the "**Tender Procedure**") organised by the **Bihor County Council**, with its registered office in the Municipality of Oradea, 5 Parcul Traian Street, Bihor County, Romania (the "**Bihor County Council**" or "**Buyer**"),

I hereby declare on my own responsibility, while knowing the sanctions provided for by the Romanian legislation regarding false statements, the following:

- The Bidder **qualifies as an airline operator within the EU**, as defined in Article 2 (11) of Regulation (EC) No 1008/2008 of the European Parliament and of the Council of 24 September 2008 on common rules for the operation of air services in the Community ("**Air Services Regulation**");
- The Bidder **has a valid operating licence granted by a competent licensing authority of an EU member state and an air operator certificate**, in accordance with Articles 3 and 6 of the Air Services Regulation, which are commensurate with the requirements of the public services obligation;
- The Bidder **has an aviation-specific liability insurance** for air operators in respect of passengers, luggage, cargo and third parties, in accordance with Regulation (EC) No 785/2004 of the European Parliament and of the Council of 21 April 2004 on insurance requirements for air carriers and aircraft operators;
- The Bidder **has not been banned from operating in Europe**; in this respect, we confirm that the Bidder is not on the European Commission's blacklist containing the airlines which fail to meet European safety standards, as listed in Annex A at the following address: https://transport.ec.europa.eu/transport-themes/eu-air-safety-list_en;
- The Bidder, its direct or indirect shareholders, entities controlling the bidder, its parent companies, subsidiaries and their legal representative, including any member of the board of directors or supervisory board, employees or their respective nominees, **are not or have not been subject to any international sanctions imposed by the United Nations, the European Union or any other authority having jurisdiction upon them or is not located in a country that is included in the European Union's blacklists**;

- The Bidder **has at his disposal a fleet consisting of a minimum of 50 owned or leased (wet lease) turbo-jet aircraft**, namely _____ planes;
- The Bidder **has the capacity to ensure that the aircraft used in the operation of the scheduled air services has at least 75 seats**;
- The Bidder **has the capacity to provide and will ensure a replacement aircraft which meets the requirements herein within 12 hours, in case of malfunctions with an existing aircraft**;
- The Bidder **has the capacity to ensure the launch and operation of the flights provided for in Section 2** of the Invitation to Tender;
- The Bidder **has at least 15 (fifteen) years of experience in scheduled air services for passengers**, namely _____ years;
- The Bidder **has operated actively and constantly, without interruptions, on scheduled flights during the last 15 (fifteen) years**;
- The Bidder **has ensured the transport of at least 10 (ten) million passengers in the last 15 (fifteen) years of operation** (cumulative for all the years), namely _____ passengers;
- The Bidder **has access to an international reservation and ticketing system valid in Romania and has (or will ensure at the start of operations) an interline agreement with through-pricing and luggage-handling arrangements with at least five airlines**. Information concerning prices and timetables shall be included in the international reservations and ticketing system. Additionally, tickets shall be available on a GDS platform and own online website;
- The Bidder will immediately inform the County of Bihor if there will be any changes in this statement at any time during the Tender Procedure.

I, The Undersigned, hereby confirm that the information provided is complete and accurate in each and every detail and I understand that the Buyer has the right to request, for the purpose of verifying and confirming the statements, any additional information related to the aspects verified. Therefore, I hereby undertake to present to the Buyer, at its request, at any time during the Tender Procedure, the necessary documents to demonstrate what is stated herein.
